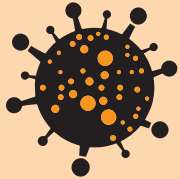

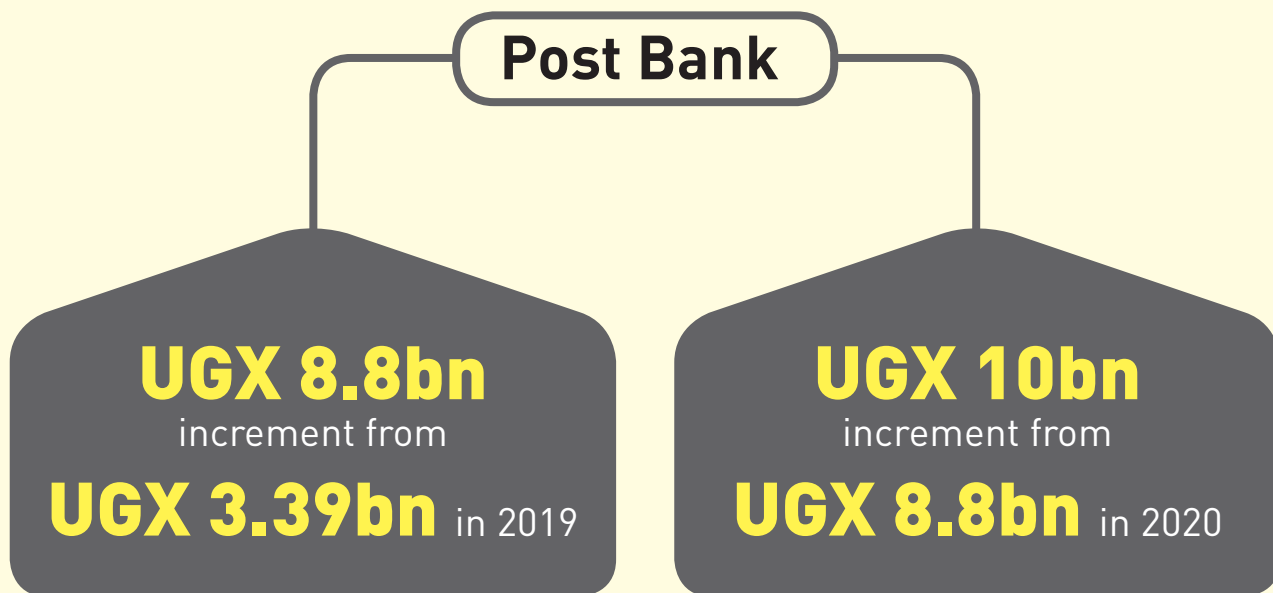

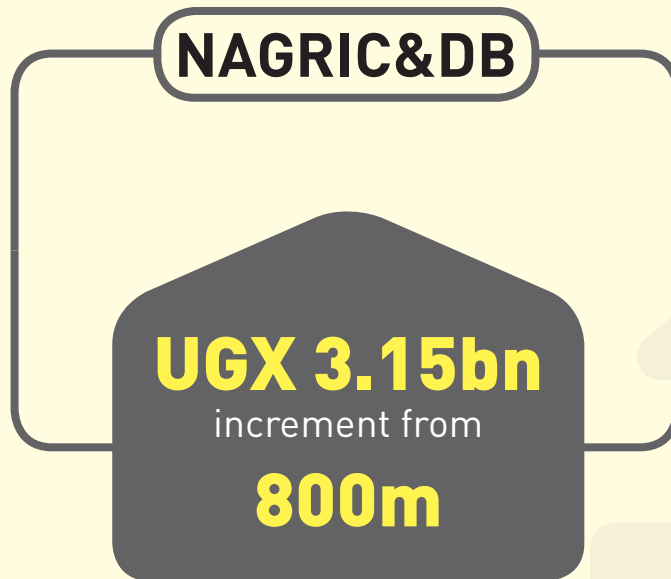


# Financial Increments

# Human interest interventions

SH-ACU intervened in mismanaged cases affecting ordinary Wanainchi.

**01** Baby swapped at birth for a dead one returned to rightful parents

**02** 8 year old Winnie Mutesi saved from severe torture, the perpetrator, her aunt was **arraigned and convicted.**

**03** **Intervened and arraigned** in courts of law the police officers implicated in the murder of Serunje Vincent. The police had initially ruled out foul play.



**04** Prevented eviction of over 1000 residents in **Kamaliba, Mpigi district.**

**05** **Arraigned in court** false claimants who were harassing over 10,000 **Ssisa** residents, in **Wakiso district.**

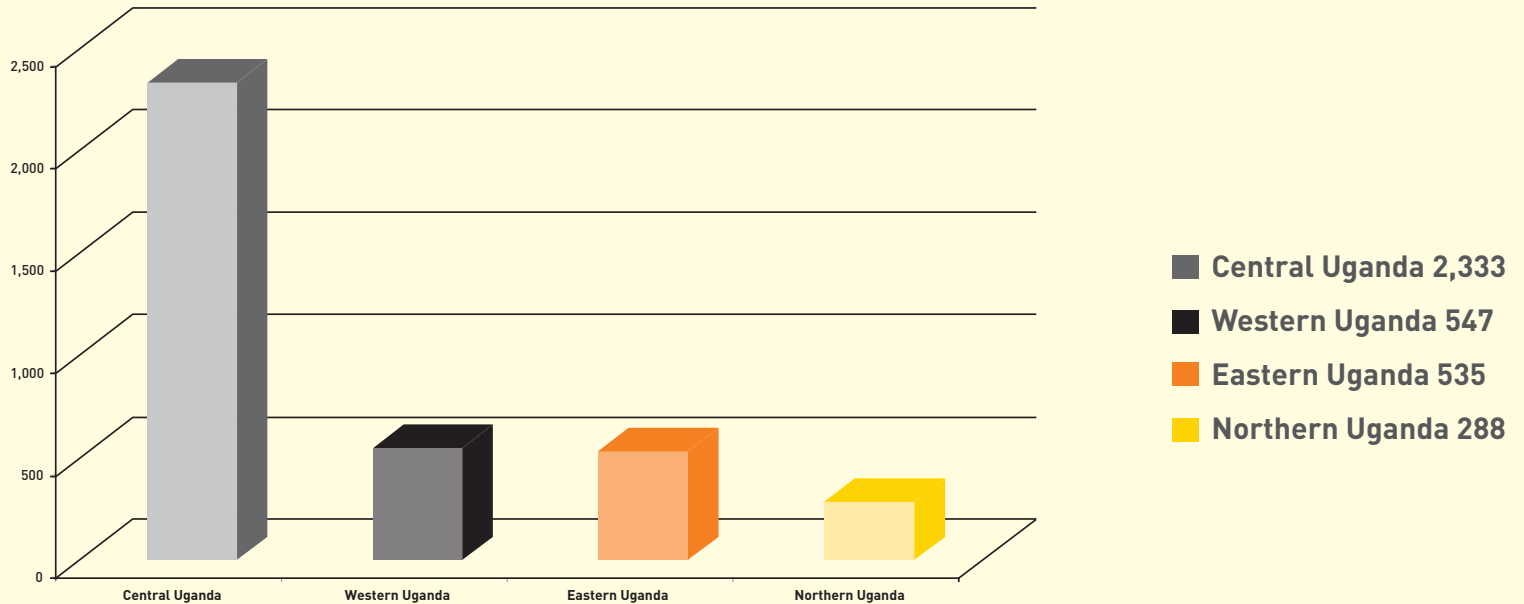

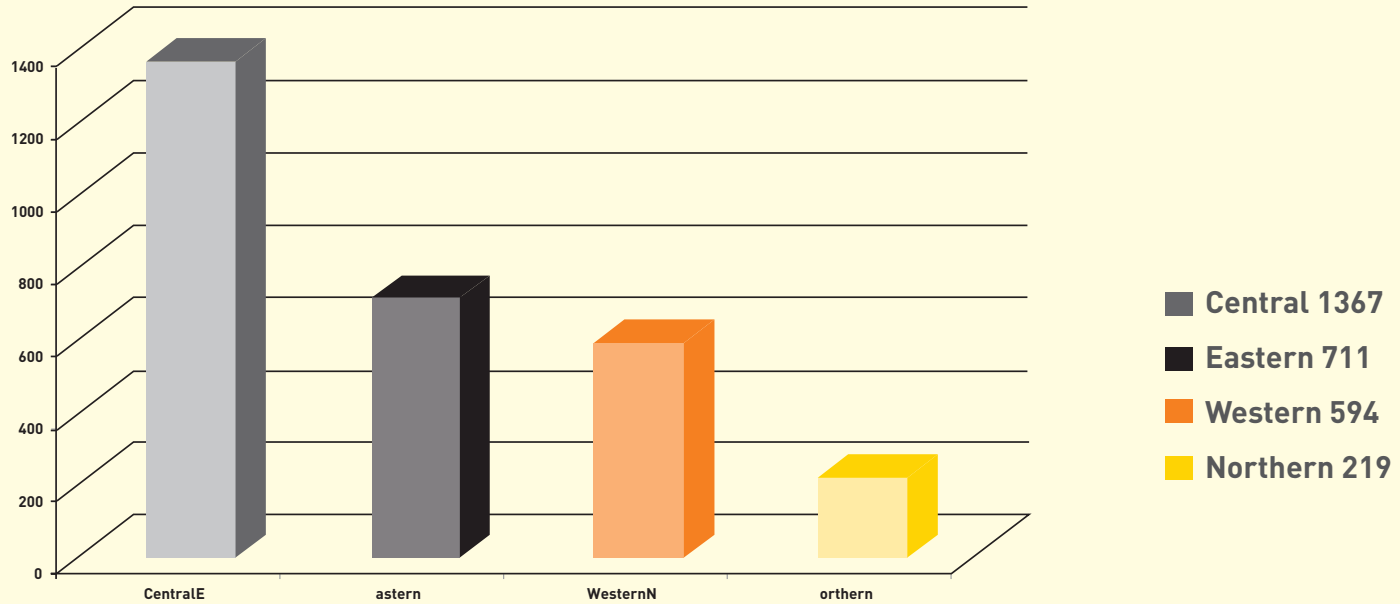
